PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #35. Approved thawing methods Provide proper thawing methods for frozen foods and drinks. Observed milk thawing at room temperature and recorded at 60 °F (cos). Placed milk in walk in cooler for proper cold holding and thawing techniques. CODE REFERENCE: 64E-11.003(2). Thawing of PHF/TCS foods shall be done in accordance with Rule requirements.</p>
<p>Violation #38. Insects, rodents, & animals not present Provide extermination for affected kitchen areas. Observed ants present on hand washing sink and food prep area. Provide over head air curtain for rear door leading to dumpster recepticals. CODE REFERENCE: 64E-11.003(5)(f). Effective measures shall be taken to control the presence of pests in the food establishment. Unless otherwise approved, live animals shall not be allowed.</p>
